## AN ACT

1 2 4 5 6 7 8 9 10	Amending the act of July 19, 1979 (P.L.130, No.48), entitled "An act relating to health care; prescribing the powers and duties of the Department of Health; establishing and providing the powers and duties of the State Health Coordinating Council, health systems agencies and Health Care Policy Board in the Department of Health, and State Health Facility Hearing Board in the Department of Justice; providing for certification of need of health care providers and prescribing penalties," in general provisions, providing for acute care mental health bed registry and referrals.
11	The General Assembly of the Commonwealth of Pennsylvania
12	hereby enacts as follows:
13	Section 1. The act of July 19, 1979 (P.L.130, No.48), known
14	as the Health Care Facilities Act, is amended by adding a
15	section to read:
16	Section 901.1. Acute care mental health bed registry and
17	referrals.
18	(a) The department shall develop and administer an Internet
19	web-based acute care mental health bed registry to facilitate
20	the temporary hospitalization and treatment of individuals who
21	meet the criteria for inpatient examination and treatment under

1	Article II or III of the act of July 9, 1976 (P.L.817, No.143),
2	known as the "Mental Health Procedures Act." The department
3	shall make the registry available to health care professionals
4	and their designees who are treating patients in need of mental
5	health inpatient examination and treatment.
6	(b) The department shall design the registry to collect,
7	aggregate and display the information under subsection (c).
8	(c) The registry shall include all of the following
9	information:
10	(1) General descriptive information for each
11	participating facility, including contact information and the
12	type of treatment and services available at each
13	participating facility.
14	(2) Real-time information, updated at least daily, on
15	the number of acute care mental health beds available at the
16	participating facility.
17	(3) For each available acute care mental health bed at a
18	participating facility, the type of patient that may be
19	admitted.
20	(4) The level of security provided at each participating
21	<u>facility.</u>
22	(5) Any other information that may assist a health care
23	professional in identifying an appropriate acute care mental
24	health bed for an individual in need of inpatient examination
25	and treatment.
26	(d) The department shall design the registry to allow
27	health care professionals and their designees to search the
28	registry for an appropriate acute care mental health bed for an
29	individual in need of inpatient examination or treatment.
30	(e) In order to be eligible to access the registry, a

3	the department for inclusion in the registry, including
4	providing daily real-time information under subsection (c);

6	(2) arrange for the facility's contact information to be
7	monitored and accessed at any time in accordance with the
8	department's regulations promulgated under subsection (h).
9	(f) The department may contract with a third party to
10	develop and administer the registry.
11	(g) The department shall publish a notice in the
12	Pennsylvania Bulletin providing for the date when the department
13	completed the development of the registry.
14	(h) The department shall promulgate regulations necessary to
15	implement this section.
16	(i) As used in this section, the following words and phrases
17	shall have the meanings given to them in this subsection:
18	"Acute care mental health bed." A bed located at a mental
19	health facility that provides acute care mental health services.
20	"Facility." A mental health facility.
21	"Health care professional." An individual licensed as a
22	physician, osteopath, physician assistant or certified
23	registered nurse practitioner.
24	"Mental health facility." A distinct part unit of a general
25	hospital licensed by the department under this act or a facility
26	that exclusively cares for the mentally ill and is licensed by
27	the Department of Human Services under the "Mental Health
28	Procedures Act" and Article X of the act of June 13, 1967
29	(P.L.31, No.21), known as the "Human Services Code," that
30	provides inpatient mental health examination and treatment. The
