## AN ACT

- Amending Title 65 (Public Officers) of the Pennsylvania 1 Consolidated Statutes, in lobbying disclosure, further providing for registration, for reporting, for prohibited 3 activities, FOR ADMINISTRATION, for penalties and for 4 registration fees, fund established, system and regulations. 5 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Sections 13A04(a), (d) and (e)(1), 13A05(a), (b)
- (4), (6) and (8) and (d), 13A07(f)(2), 13A08(B), 13A09(c)(1) and <--
- 13A10(c) of Title 65 of the Pennsylvania Consolidated Statutes
- 11 are amended to read:
- 12 § 13A04. Registration.
- 13 General rule. -- Unless excluded under section 13A06
- 14 (relating to exemption from registration and reporting), a
- 15 lobbyist, lobbying firm or a principal must register with the
- department <u>electronically using the computerized filing system</u> 16
- developed by the department that is consistent with the purposes 17
- 18 of this chapter within ten days of acting in any capacity as a

- 1 lobbyist, lobbying firm or principal. Registration shall be
- 2 biennial and shall begin January 1, 2007.

- 4 (d) Amendments.--
- 5 (1) If there is a change of information required for the
- 6 registration statement under subsection (b)(1) or (2) or (c),
- 7 an amended registration statement shall be filed with the
- 8 department <u>electronically using the computerized filing</u>
- 9 system developed by the department that is consistent with
- 10 <u>the purpose of this chapter</u> within 14 days after the change
- 11 occurs.
- 12 (2) When there is a change in information required for
- the registration statement under subsection (b) (3), an
- 14 amended registration statement shall be filed with the
- department <u>electronically using the computerized filing</u>
- 16 <u>system developed by the department that is consistent with</u>
- 17 <u>the purpose of this chapter</u> within 14 days of the end of the
- 18 year in which the change occurs.
- 19 (e) Termination.--
- 20 (1) A lobbyist, lobbying firm or principal may terminate
- 21 registration by filing notice of termination with the
- 22 department[.] <u>electronically using the computerized filing</u>
- 23 system developed by the department that is consistent with
- the purpose of this chapter.

- 27 (a) General rule. -- A registered principal shall, [under oath <--
- 28 or affirmation] SUBJECT TO THE PENALTIES UNDER 18 PA.C.S. § 4904 <--
- 29 (RELATING TO UNSWORN FALSIFICATION TO AUTHORITIES), file
- 30 quarterly expense reports with the department electronically

- 1 using the computerized filing system developed by the department
- 2 that is consistent with the purpose of this chapter no later
- 3 than 30 days after the last day of the quarter.
- 4 (b) Content.--
- 5 \* \* \*
- 6 (4) A lobbying firm or a lobbyist not associated with a
- 7 lobbying firm shall sign the reports <u>electronically</u> submitted
- 8 by each principal for whom the lobbying firm or lobbyist is
- 9 registered to attest to the validity and accuracy to the best
- of the attestor's knowledge. A lobbying firm or lobbyist may
- 11 attach a statement to the <u>electronic</u> report of a principal,
- 12 describing the limits of the knowledge of the lobbying firm
- or lobbyist concerning the information contained in the
- 14 expense report.

- 16 (6) A lobbying firm or a lobbyist not associated with a
- 17 lobbying firm shall submit an expense report <u>electronically</u>
- 18 <u>using the computerized filing system developed by the</u>
- 19 <u>department that is consistent with the purpose of this</u>
- 20 <u>chapter</u> if during the reporting period the lobbying firm or
- 21 lobbyist engaged in lobbying which was not contained in any
- 22 expense report filed by a principal or principals
- 23 represented.

- 25 (8) A lobbying firm or a lobbyist not associated with a
- lobbying firm shall submit a report <u>electronically using the</u>
- 27 <u>computerized filing system developed by the department that</u>
- 28 <u>is consistent with the purpose of this chapter</u> if the
- lobbying firm or lobbyist engaged in lobbying on behalf of
- any entity that is exempt under section 13A06(7), (8), (9) or

- 1 (10) (relating to exemption from registration and reporting).

- 3 (d) Thresholds for reporting. -- An expense report required
- 4 under this section shall be filed <u>electronically using the</u>
- 5 computerized filing system developed by the department that is
- 6 consistent with the purpose of this chapter when total expenses
- 7 for lobbying exceed \$2,500 for a registered principal in a
- 8 reporting period. In a reporting period in which total expenses
- 9 are \$2,500 or less, a statement to that effect shall be filed
- 10 <u>electronically using the computerized filing system developed by</u>
- 11 the department that is consistent with the purpose of this
- 12 chapter.

- 16 (f) Unlawful acts.--
- 17 \* \* \*
- 18 (2) The commission may receive complaints regarding
- violations of this subsection. If the commission determines a
- violation of this subsection has occurred, the commission,
- 21 after investigation, notice and hearing:
- 22 (i) shall impose an administrative penalty in an
- 23 amount not to exceed [\$2,000] \$4,000; and
- 24 (ii) may prohibit a lobbyist from lobbying for
- economic consideration for up to five years.

- 29 (B) FORMS. -- THE DEPARTMENT SHALL PRESCRIBE REGISTRATION AND
- 30 REPORTING FORMS TO BE USED UNDER THIS CHAPTER. THE FORMS SHALL

- 1 BE AVAILABLE ON A PUBLICLY ACCESSIBLE INTERNET WEBSITE. ALL
- 2 INFORMATION REQUESTED ON THE FORMS SHALL BE PROVIDED TO THE BEST
- 3 OF THE KNOWLEDGE, INFORMATION AND BELIEF OF THE PERSON REQUIRED
- 4 TO FILE AND SHALL BE SIGNED [UNDER OATH OR EQUIVALENT
- 5 AFFIRMATION] SUBJECT TO THE PENALTIES UNDER 18 PA.C.S. § 4904
- 6 (RELATING TO UNSWORN FALSIFICATION TO AUTHORITIES).

- 10 (c) Negligent failure to register or report.--
- 11 (1) Negligent failure to register or report as required
- by this chapter is punishable by an administrative penalty
- not exceeding [\$50 for each late day.] the following:
- 14 (i) For the first ten late days, \$50 for each late
- 15 <u>day</u>.
- 16 <u>(ii) For each late day after the first ten late days</u>
- 17 through the 20th late day, \$100 for each late day.
- 18 <u>(iii) For each late day after the first 20 late</u>
- days, \$200 for each late day.

- 24 (c) Computerized filing system. -- The department shall
- 25 implement a fully accessible system to accommodate the use of
- 26 computerized filing. [Each registrant shall elect on an annual
- 27 basis whether the registrant will file all of the documents
- 28 required by this chapter either electronically or on paper with
- 29 the department.] The department shall post all filings on its
- 30 publicly accessible Internet website within seven days of

- 5 (1) and 13A05(a), (b)(4), (6) and (8) and (d) shall take
- 6 effect January 1, 2018.
- 7 (2) The remainder of this act shall take effect
- 8 immediately.
