- 5 (a) Authorization .-- In accordance with the powers under
- section 503-A(a) and duties under section 503-A(c), the State 6
- Inspector General may issue a subpoena relating to any matter 7 pertinent to an examination to a person under the State
- Inspector General's jurisdiction or to an individual or a person 9
- receiving services from or through an executive agency. If a 10
- person fails or refuses to obey a subpoena, the State Inspector 11
- General may petition a court of competent jurisdiction to enter 12
- an order compelling the witness to appear and testify or produce 13
- documentary evidence. Failure to obey the court order shall be 14
- 15 punishable as contempt of court.
- (b) Form and effect. -- A subpoena under subsection (a) shall 16 17 be in substantially the same form and have the same force and
- effect as a subpoena issued by a court of common pleas. The 18
- State Inspector General shall have the benefit of the process of 19 20
- the appropriate court of common pleas if necessary to enforce a 21 subpoena.
- (c) Confidentiality. -- A subpoena issued under this section 22 must clearly indicate on the face of the subpoena that the 23
- subpoena is issued in connection with a confidential proceeding 24
- and a breach of confidentiality by the person subpoenaed may 25 26 result in a civil penalty or misdemeanor.
  - (d) Fees. -- Witnesses subpoenaed under this section shall be compensated under 42 Pa.C.S. § 5903 (relating to compensation and expenses of witnesses).
- 30 Section 506-A. Criminal charges.
- 31 Notwithstanding any other provision of law, the State Inspector General shall have the power to investigate and may 32 file criminal charges for a violation of any of the following: 33
  - (1) Section 481 of the act of June 13, 1967 (P.L.31,
- No.21), known as the Human Services Code. 35 36
  - (2) Section 1408 of the Human Services Code.
- (3) 18 Pa.C.S. § 7313 (relating to buying or exchanging 37
- 38 Federal food order coupons, stamps, authorization cards or 39 access devices).

(5) Specific recommendations concerning the improvement 20 of any State program to further reduce waste, fraud and 21 22 abuse.
