Kim was born and raised in York where she attended York City schools and is a proud graduate of William Penn Senior High School and attended Bloomsburg University In 1984 joined the United States Air Force where she served honorably until 1994 achieving the rank of E-6. Among her medals and citations, she received the National Defense Service Medal and the Air Force Good Conduct Medal with 2 devices.



In addition to her duties as mayor, Kim currently serves or has served on the Boards of York Hospital, the Martin Library, the York County Community Foundation, and Habitat for Humanity specifically because of their missions to serve the York community.
