**EXECUTIVE DIRECTOR**

Kevin F. O'Toole has served as the Executive Director of the Pennsylvania Gaming Control Board since June, 2009, bringing 28 years of experience to the agency's top position. In his role with the PGCB, Mr. O'Toole is responsible for the direction, execution and coordination of all activities related to the regulation of gaming by the 300 plus employee agency.

During his tenure, Mr. O'Toole has worked to refine the operations of the PGCB to assure that it is fulfilling its mission while providing strict but fair oversight. In addition, he has met extensively with state legislators, appeared at committee hearings, and utilized his gaming regulatory expertise toward implementing the 2010 legislation that amended the Gaming Act with needed and workable reforms, along with adding table games in existing state casinos.

Prior to joining the PGCB, O'Toole was the Executive Director of the Oneida Indian Nation Gaming Commission beginning in July 1997 and was later appointed as a Commissioner in February 2007. Previously, O'Toole was a Deputy Attorney General with the New Jersey Division of Gaming Enforcement from 1981 to 1997.

O'Toole is a graduate of the Wharton School of Finance and Commerce at the University of Pennsylvania and received his law degree from Rutgers University School of Law – Camden.

**William H. Ryan, Jr.**

**CHAIRMAN**

On August 19, 2011, Governor Tom Corbett appointed William H. Ryan Jr. to a three-year term as Chairman of the Pennsylvania Gaming Control Board.

Prior to his position with the Board, Mr. Ryan served for 14 years with the Office of Pennsylvania Attorney General including four months as Acting Attorney General beginning on January 18, 2011.

Earlier, Ryan served as First Deputy to both Attorneys General Corbett and Jerry Pappert, a role in which he oversaw legal and administrative matters for the agency. Prior to that, Ryan headed the Criminal Law Division under Attorney General Mike Fisher, directing investigations involving organized crime, narcotics trafficking and other public safety matters.

Ryan began his legal career with the Delaware County District Attorney's Office in 1972, working as a legal intern while in law school, then rising to the position of first assistant district attorney in 1981. In 1987, Ryan was elected District Attorney of Delaware County, then re-elected to that position in 1991. During his tenure as District Attorney, Ryan also served President of the Pennsylvania District Attorneys Association in 1993-94.

Ryan graduated from St. Joseph's University and Villanova Law School and lives in Delaware County with his wife Debra. They have two sons, Dan and Chris.
