BILL AND AMENDMENT SUMMARY House Bill 1610, Printer's No. 2441 Prime Sponsor: Vereb

A. **SYNOPSIS**:

HB 1610 requires the development of guidelines to educate coaches, parents and student-athletes about the warning signs of sudden cardiac arrest; provides for the removal of student-athletes from participating in a sporting event if they show symptoms of sudden cardiac arrest; requires new training for coaches to recognize the symptoms of sudden cardiac arrest; and provides penalties for violation of the act.

B. BILL ANALYSIS:

HB 1610 shall be known as the "Sudden Cardiac Arrest Prevention Act." It requires the Department of Education and Department of Health to develop guidelines and other relevant materials to educate students, parents and coaches about the warning signs of sudden cardiac arrest, including the risks associated with continuing to play or practice when experiencing those symptoms. The departments may use existing materials developed by organizations such as Parent Heart Watch and Sudden Arrhythmia Death Syndromes. They must post the guidelines on their respective websites.

Student-athletes at schools participating in the Pennsylvania Interscholastic Athletic Association (PIAA) must annually and prior to participation in an *athletic activity* sign and return to their school an acknowledgement of receipt and review of the sudden cardiac arrest symptoms information sheet developed by the departments. An *athletic activity* is defined by the bill as interscholastic athletics; club-sponsored sports, including cheerleading and other sports activities that are school-affiliated; non-competitive cheerleading that is sponsored by or associated with a school entity; and all practices, interschool practices and scrimmages for all of these activities.

A school entity may also hold an informational meeting prior to the start of each athletic season to brief students, parents, coaches and other school officials about sudden cardiac arrest.

A student-athlete that exhibits any signs or symptoms of sudden cardiac arrest while participating in an athletic event, as determined by a game official, coach, certified athletic trainer, licensed physician or other official, shall be removed from play. If the student-athlete has a history of these symptoms at any time prior to or following an athletic activity, the student shall not return to participation. A student-athlete removed from play may only participate in an

athletic activity once they are evaluated and cleared for return in writing by a licensed physician, certified registered nurse practitioner or, if the athlete is referred to a cardiologist, a cardiologist.

School boards shall establish the following minimum penalties for a coach who fails to remove a student-athlete from play: 1) for a first violation, suspension from coaching any athletic activity for the remainder of the season; 2) for a second violation, suspension from coaching for the remainder of the season and the next season; 3) for a third violation, permanent suspension from coaching.

Coaches shall annually complete a sudden cardiac arrest training course offered by a provider approved by the Department of Health. Coaches shall not be eligible to coach until completion of the training.

The sponsors of youth athletic activities conducted outside a school entity are encouraged to follow the guidance issued by the departments.

Nothing in this act shall be construed to abridge or limit any rights provided under a collective bargaining agreement or any rights provided under the act of July 23, 1970 (P.L.563, No.195), known as the Public Employe Relations Act; or create, establish, expand, reduce, contract or eliminate any civil liability on the part of any school entity or school employee.

The bill takes effect in 60 days.

C. <u>SUMMARY OF RELEVANT EXISTING LAW:</u>

HB 1610 is a freestanding act. It is similar to Act 101 of 2011, which addressed concussions and head injuries in student-athletes.

D. AMENDMENT A09999 SUMMARY:

A09999 is a technical amendment that does the following:

- Clarifies that sudden cardiac arrest can have one or more symptoms.
- Allows a student who is removed from play or has exhibited signs of sudden cardiac arrest prior to or after an athletic activity to be cleared to participate in an athletic activity again by a licensed physician, certified registered nurse practitioner or cardiologist.
- Removes a confusing referral reference, thus allowing a cardiologist to automatically sign off on the student-athlete.
- Encourages sponsors of youth athletic activities *not associated with a school entity* to follow the guidance of the act.
- Amends the section pertaining to collective bargaining agreements to read that the act shall not abridge or limit any rights provided under a current or existing collective bargaining agreement, thus allowing any future collective bargaining agreement to meet the requirements of the act.

AN ACT

- 1 Establishing standards for preventing sudden cardiac arrest and

- "Department." The Department of Health of the Commonwealth.
- "Interscholastic athletics." As defined in section 1602-A of
- 13 the act of March 10, 1949 (P.L.30, No.14), known as the Public
- 14 School Code of 1949.
- "School entity." As defined in section 1602-A of the act of
- 16 March 10, 1949 (P.L.30, No.14), known as the Public School Code
- 17 of 1949.
- 18 Section 3. Sudden cardiac arrest.
- 19 (a) Educational materials.--
- 20 (1) The department and the Department of Education shall
- 21 develop and post on their publicly accessible Internet
- 22 websites guidelines and other relevant materials to inform
- and educate students participating in or desiring to
- 24 participate in an athletic activity, their parents and their
- 25 coaches about the nature and warning signs of sudden cardiac
- arrest, including the risks associated with continuing to
- 27 play or practice after experiencing the following symptoms:
- 28 fainting, difficulty breathing, chest pains, dizziness and
- 29 ABNORMAL racing heart rate.
- 30 (2) In developing the guidelines and materials, the

- department and the Department of Education may utilize
- 2 existing materials developed by organizations, such as Parent
- 3 Heart Watch and Sudden Arrhythmia Death Syndromes.
- 4 (3) A student participating in or desiring to
- 5 participate in an athletic activity and the student's parent
- or guardian shall, each school year and prior to

- 9 receipt and review of the sudden cardiac arrest symptoms and
- 10 warning sign information sheet developed under this

- 12 (b) Informational meeting. -- A school entity may hold an
- 13 informational meeting prior to the start of each athletic season
- 14 for all ages of competitors regarding the symptoms and warning
- 15 signs of sudden cardiac arrest. In addition to students,

- 17 meetings may include physicians, pediatric cardiologists and

- 19 (c) Removal from play.--
