## AN ACT

- 1 Providing for the disposal of hospice or home health care patient medication.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Hospice and
- 7 Home Health Prescription Medication Disposal Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- "Caregiver." An adult individual who regularly provides
- 13 personal care to the patient, whether paid or unpaid, or
- 14 regularly resides in the patient's home. This individual shall
- 15 not be an employee of the home health agency or hospice that is
- 16 disposing of the patient's prescription medication.
- 17 "Family member." A patient's spouse, parent, adult sibling,

- 1 adult child or adult grandchild.
- 2 "Health care representative." A person who is authorized by
- 3 law or court order to make health care decisions on behalf of a
- 4 patient.
- 5 "Patient." An individual who is currently receiving care
- 6 from a home health agency or hospice licensed under the act of
- 7 July 19, 1979 (P.L.130, No.48), known as the Health Care
- 8 Facilities Act.
- 9 Section 3. Disposal of unused prescription medication.
- 10 (a) Authorization. -- A home health agency or hospice is
- 11 authorized, upon the death or discharge of a patient and with
- 12 the permission of the patient or the patient's family member,
- 13 caregiver or health care representative, to accept for disposal
- 14 a patient's unused prescription medications that were
- 15 prescribed, dispensed or otherwise used by the patient while
- 16 under the care of the home health agency or hospice.
- 17 (b) Prescription medication disposal policy. -- A home health
- 18 agency or hospice shall:
- 19 (1) Establish a written policy setting forth procedures
- for accepting and disposing of unused prescription
- 21 medications.
- 22 (2) At the time of admission:
- 23 (i) furnish a copy of the written policy to each
- 24 patient or the patient's health care representative; and
- 25 (ii) designate an employee representative who shall
- discuss the procedures and requirements for surrendering
- 27 unused prescription medications with the patient or the
- 28 patient's health care representative.
- 29 (c) Surrender of prescription medication.--Unused
- 30 prescription medications surrendered to a home health agency or

- 1 hospice under this section shall be surrendered to a nurse
- 2 employed by the agency.
- 3 (d) Disposal of prescription medication. -- A nurse accepting
- 4 the unused prescription medication under this section shall
- 5 dispose of the medication in the presence of a witness at the
- 6 site where care is provided. The nurse may not transport the
- 7 unused prescription medications off-site for disposal or for any
- 8 other purpose.
- 9 (e) Timing of disposal. -- The disposal of a patient's
- 10 medication shall take place:
- 11 (1) during the final in-home visit by the nurse; or
- 12 (2) within five business days of the death or discharge
- of the patient, whichever occurs first.
- 14 (f) Documentation. -- The following shall apply:
- 15 (1) A nurse who accepts and disposes of an unused
- prescription medication under this section shall document all
- of the following:
- 18 (i) The name and quantity of each medication
- 19 surrendered.
- 20 (ii) The name of the person authorizing the
- 21 surrender and the relationship of the person to the
- 22 patient.
- 23 (iii) The date and method of disposal.
- 24 (iv) The name of the person witnessing the disposal.
- 25 (2) The person authorizing the surrender of medication
- shall be provided with the opportunity to review, verify and
- 27 sign the documentation required under this subsection.
- 28 (g) Records.--A home health agency or hospice shall maintain
- 29 for a period of five years a record of the documentation
- 30 required under subsection (f).

- 1 Section 4. Effective date.
- 2 This act shall take effect in 60 days.
