



### Acting Adjutant General, Pennsylvania National Guard

Brigadier General Anthony J. Carrelli assumed duties as Acting Adjutant General on January 14, 2016. In this cabinet-level position with the Pennsylvania Department of Military and Veterans Affairs, headquartered at Ft. Indiantown Gap, Anville, PA, General Carrelli is responsible for the command, control and supervision of National Guard units – Army and Air – allocated to the Commonwealth of Pennsylvania, six state-owned veterans' homes and programs for Pennsylvania's one million veterans.



General Carrelli graduated from the U.S. Air Force Academy with a Bachelor of Science Degree and was commissioned as a second lieutenant in 1985. He served in the active duty Air Force for several years as a T-37, AT-38, and A-10 pilot. Following his release from active duty, General Carrelli joined the Pennsylvania Air National Guard where he served as commander of both the 111 Fighter Wing and the 171 Air Refueling Wing, and Deputy Adjutant General – Air, before assuming duties as Acting Adjutant General. General Carrelli has deployed in numerous operations to include Desert Storm, Southern Watch, and most recently Operations Enduring Freedom and Iraqi Freedom.
